The need for CMDR

Crisis Management is one of the three NATO core tasks. Today the Alliance is able to take decisions in crisis and emergency, and to act under significant threat and time pressure. NATO develops capabilities to be ready, on a case-by-case basis and by consensus, to contribute to effective crisis and emergency prevention and to engage actively in crisis and emergency management, including with non-Article 5 Crisis Response Operations.



MATO's role in crisis and disaster response goes beyond pure military actions and includes Crisis and Disaster Response Operations aimed to prevent and protect populations and lifesaving systems against natural, technological, humanitarian emergencies and disasters.

NATO Summits Declarations and the Strategic Concept emphasize the need of enhancing Alliance contribution with a Comprehensive Approach to crisis management, based on the recognition that pure military intervention alone cannot resolve or help recovering after crises or disasters.

The enlargement of NATO contribution to the Euro-Atlantic security requires smart prioritization, specialization and cooperation with other major security players like EU and UN in the area of capability building, including enhanced and coordinated effort of sharing knowledge, analyses, best practices and lessons learned.

NATO, Nations and Partners closer cooperation in crisis and disaster response domain requires development of appropriate military and civilian capabilities for information sharing, for building common situational awareness with Early Warning and Alert Systems, for crisis and disaster response planning and operations.






